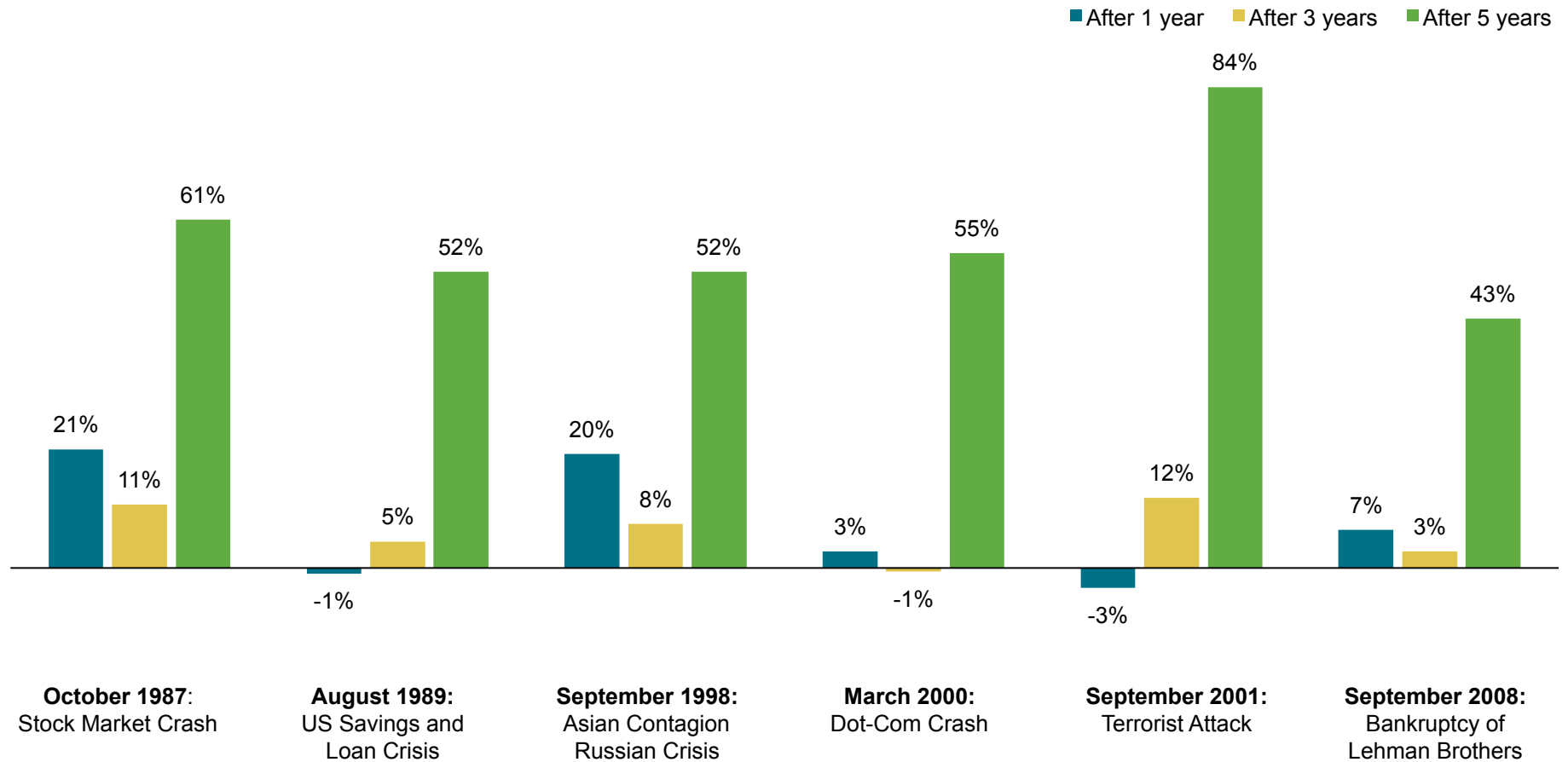


The Market's Response to Crisis
